## What is CUI?

A law, regulation, or government-wide policy may require or permit an agency to handle using safeguarding or dissemination controls information that the government creates or possesses, or that a company develops or owns on the government's behalf. This type of information is known as controlled unclassified information (CUI). You must know about it regarding **what is the purpose of the isoo cui registry**.

CUI does not, however, comprise classified information or data that a non-executive branch business owns and keeps on hand in its own systems and that was not obtained from, developed by, or acquired by, or on behalf of, an executive branch agency or a company operating on the agency's behalf.

There are three ways that law, regulation, or government policy may require or permit safeguarding or dissemination controls: by requiring or allowing agencies to control or protect the information without providing any specific controls, which makes the information CUI Basic. ## **Purpose of the CUI Program**

While the information produced, used, stored, and shared by federal agencies frequently does not fulfill the criteria to be classified as nuclear or national security information, it nevertheless needs to be protected from illegal access and disclosure.

According to and in accordance with legislation, regulation, or general government policy, protection is necessary for reasons of privacy, law enforcement, or other considerations. In the past, the Executive Branch had a patchwork of markings since each agency had its own procedures for handling critical unclassified material. This led to confusion among branch employees. On September 14, 2016, ISOO released the Title 32 Part 2002 (CUI) Code of Federal Regulations (CFR) Final Rule. The "Implementing Guidance" for the CUI Program was contained in this Final Rule. On March 6, 2020, DOD Instruction (DODI) 5200.48, Controlled Unclassified Information, was published by the Office of the Under Secretary of Defense for Intelligence and Security (OUSD (I&S)). This order provides policy for CUI across DOD, assigns duties, and specifies processes in accordance with (IAW):

- E.O. 13556;
- Part 2002 of Title 32 CFR (Final Rule) and Sections 252.204 to 252.209 of the Defense Federal Acquisition Regulation Supplement (DFARS)
- 7008 and 252.204-7012.

The Information Security Oversight Office (ISOO) maintains the ISOO CUI Registry (Isoo.gov), which is the definitive source of Controlled Unclassified Information (CUI) about US Government systems and procedures (ISOO).

The registry offers the guidelines and open access required to make it easier to implement CUI compliance requirements across a range of US government systems, programs, and activities. The registry ensures that information is appropriately labeled, stored, and distributed among authorized users by establishing, maintaining, and granting public access to CUI.
